

# VICTORY HOUSE PRIVATE SCHOOL 2022

## Acceptance & Method of Payment of Compulsory School Fees

### **Primary School (Grades 00 to Grade 7)**

Grades 00: 12 X R2,000.00 or R24,000-00 (Twenty four thousand rand) p.a.  
Grades 0: 12 X R3,150-00 or R37,800-00 (Thirty seven thousand, eight hundred rand) p.a.  
Grades 1 to 3: 12 X R4,100-00 or R49,200-00 (Forty nine thousand, two hundred rand) p.a.  
Grades 4 to 7: 12 X R4,250-00 or R51,000-00 (Fifty one thousand rand) p.a.

After-Care fees: 12 X R1,300-00 or R15,600-00 (Fifteen thousand, six hundred rand) p.a.  
Including school holidays (not December / part January) when After-Care is closed.  
The fee is calculated over 46 weeks, although payment is made over 12 payments.  
(i.e. if worked out for pro-rata attendance and/or notice, amount calculated at R340-00 per week)  
After Care is only available for Primary School learners.

### **High School (Grades 8 to Grade 12)**

Grades 8 to 9: 12 X R4,750-00 or R57,000-00 (Fifty seven thousand rand) p.a.  
Grades 10 to 12: 12 X R4,900-00 or R58,800-00 (Fifty eight thousand, eight hundred rand) p.a.  
Additional requirement for learners doing CAT: R3,000-00 pa (payable at R250 per month, paid with the school fees)  
Grade 12 examination re-writes: R500-00 per paper written (To be paid when registering for each exam)

### **Stationery Fees**

All Grade 0 to 7 learners are required to purchase the stationery pack obtained by the school so as to ensure uniformity in the different stationery items. This also allows the school to obtain the best prices when the order is for the whole school.

Grades 0 to 7: R 1,500-00 (Includes personal stationery used at school)  
High School: R 1,000-00 (To cover the cost of photo-copy paper, tissues and other consumable stationery used at school. This does not cover learner's personal stationery)

### **Text Books**

Grades 0 to 7: All text books will be supplied by the school when text books are required.  
High School: All required text books to be purchased by the learner. (Details to follow)

### **Registration Fee**

The Registration Fee for all learners is R2,000-00 (Two thousand rand). This fee is a non-refundable amenities fee.  
The fee is only payable once, when initially registering. Not every year.  
In the case of registration fee for the Grade 00 class, the registration fee will be deducted from the first month's school fee (Grade 00 registration fee is non-refundable / not deductible if the learner fails to attend the first months schooling).

### **The Fees are payable as follows**

#### ***Registration Fee***

Immediately upon enrolment. Once paid, a place is reserved for the learner.  
(This is a once off fee when registering, over and above the annual school fees)

#### ***School Fees: Monthly in advance***

First month's payment by 31 December 2021 and thereafter by the last business day of each subsequent month, in twelve equal payments (i.e. 31 December 2021 continuing until 30 November 2022).

(Learners taking CAT, fee of R250-00 per month over 12 months, paid together with school fees as above)

#### ***After-Care Fees***

Fees are payable monthly in advance as above in School Fees. The fees are based upon a full-time rate and are due even if the Pupil does not attend the After-Care for some of the days. Casual attendance at the After-Care is available at R80-00 per afternoon, payable before the Pupil stays for the afternoon. (Daily rate is not applicable during school holidays)

#### ***Stationery Fees***

To be paid by 30 November 2021.

Should any month end fall within school holidays, payments for all of the above fees must still be paid by month end. In this case, payments can be made at the school in cash; alternatively, deposits can be effected directly to the school's bank account to ensure that payments are made by month end. Details of the accounts are listed on the monthly school fees statement.

#### ***Early Payment Discount***

A 5% discount will be given on the 2022 school fees, if they are paid up front and in full, on or before **31 December 2021**.

A special 10% discount will be given on the 2022 school fees, if they are paid up front and in full, on or before **30 September 2021**.

#### ***Default on Fees***

If fees fall into arrears, the full year's fee will be invoiced and the account handed to attorneys for intervention and arrangements.

Should a learner leave the school the account will be adjusted once the notice amount has been taken into account.

#### ***Notice Requirements***

When leaving the school please refer to the contract with regards to notice requirements. This also applies to After Care.

#### ***Absenteeism due to Suspensions***

Should a learner be suspended due to misconduct or absent for any reason, if more than 10 consecutive school days are missed in the year, the learner will be de-registered from Victory House.

Fees will be due until expiry of the applicable notice period or de-registration date.
